Thank you for expressing an interest in using Ch Timeless _____ in your breeding program. Attached you will find a copy of his pedigree and our policies concerning stud services. Before a commitment for breeding is made, please consider the following:

Prior to a breeding agreement, we require from you:

1. A photocopy of the bitch's AKC/CKC registration.
2. A legible four generation pedigree
3. A photocopy of your bitch's OFA hip certification
4. A recent photograph or video tape of the bitch.

Following an agreement to breed, but prior to breeding, it is required that you:

1. Provide a veterinary certificate of Brucella titer dated no more than 30 days prior to the mating. A photocopy of all the lab report is required.
2. Pay all transportation costs for the bitch.
3. Pay all veterinary costs at the time of service, while the bitch is in our care. This would include vaginal smears, artificial insemination (if the bitch is unreceptive to natural breeding)
4. Pay all expenses if using fresh chilled semen including collection kits, semen collection, shipping charges, etc.
5. Provide a record of current vaccinations including Rabies.
6. Provide names and addresses of all prospective puppy owners.
7. Agree to comply with the Code of Ethics set forth by the Keeshond Club of America.
8. Agree that puppies resulting from this breeding shall not knowingly be sold either directly, or to an agent thereof, who sells outright or consigns to a pet shop, kennel, or

individual whose purpose is mass production, wholesaling, or retailing or purebred dogs.

9. Agree that puppies resulting from this breeding shall be sold under contracts to protect their best interests. Pet puppies must be sold under Limited AKC Registration and under a spay/neuter contract.
10. The owner of the bitch further agrees to keep track of every puppy from this litter and periodically check back on the welfare of the dog.
11. The owner of the bitch agrees to be responsible for the offspring of this breeding and further agrees to take back puppies and place them or assist in placing them if the owners can no longer keep them. Bitch owner agrees that in no case will they knowingly allow puppies/dogs resulting from this breeding be allowed to be placed in a shelter, pound, or rescue.

Prior to an agreement to breed, our responsibilities to you are as follows:

1. To provide a photocopy of our stud's AKC registration
2. To provide a photocopy of our stud's OFA hip certification.
3. A four generation pedigree.
4. Provide a veterinarian certificate of a negative Brucella titer dated no more than 30 days before mating.

All proposed bitches must meet the following criteria:

1. The bitch must be in good physical condition.
2. The bitch must not have been exposed to any stud dog prior to her arrival and must be protected from exposure upon her return home.
3. The bitch must have a stable temperament.
4. The bitch must be at least twenty-four months of age but not over seven years of age.
5. The bitch must have completed her AKC Championship.
6. The bitch must not have produced a litter in the last eighteen month period.

Stud Service Policy:

The stud fee is \$_____ (US Dollars) and is to be paid when the bitch is delivered by owner. The stud fee is in no way refundable. We guarantee that an actual tie mating will occur. Two breedings will be attempted. Should artificial insemination be needed, the owner of the bitch will be notified and approval requested prior to the procedure. The owner of the bitch is responsible

for all related expenses. If the bitch fails to conceive a return service at no charge only if the owner of the bitch notifies us within fourteen days after the projected whelping date. Repeat service is applicable only to the same bitch and by the same stud. In addition, if the bitch does not whelp three live puppies, then a free stud service will provided to the original bitch, or a mutually agreeable bitch, at mutually agreeable time. All transportation charges and veterinary expenses will be the responsibility of the owner of the bitch, regardless of the outcome of the breeding. There is no charge for boarding the bitch for the first seven days. A charge of \$7 per day will apply following the seventh day.

The stud dog owner is not obligated to sign the litter registration papers on a litter resulting from this breeding until the stud fee has been paid in full. It shall be the option of the stud dog owner whether or not to do so before the stud fee is paid.

The owner of the bitch hereby releases from responsibility Timeless Kennels and Susan Morton from any and all liabilities and/or damages to said bitch while she is in the care of Timeless Kennels for breeding.

Owner of the bitch understands that violations of this contract would be detrimental to the reputation of Timeless Keeshonden and the stud dog. Owner of the bitch agrees that such violations will entitle Susan Morton and Timeless Keeshonden to payment on demand of an amount equal to three times the above-stated stud fee. Owner of the bitch further agrees that any and all suits for the breach of, or enforcement of this contract will be brought in the current state of the stud dog owner's residence and the laws of the state of the Breeder's current residence will apply.
